# **PRIVACY POLICY**

Protecting your private information is our priority. This Privacy Statement applies to <u>www.p-coc.org</u> and P-CoC Inc | Parenting Children of Color and governs data collection and usage. ## **Collection of your Personal Information**

In order to better provide you with products and services offered on our Site, P-CoC Inc may collect personally identifiable information, such as your:
